#### 1. Minutes of previous meeting

Minutes were agreed for the NTIG meeting held in December 2019.

### 2. Updates: 2<sup>nd</sup> Cycle Implementation / 3<sup>rd</sup> Cycle Planning

#### 2. LAPWRO + ASSAP

#### **LAWPRO (Sean Keating)**

- LAWPRO are progressing through the 190 priority areas for action (PAAs). There are 127 desktop assessments, 115 community meetings, 80 ASSAP meetings, and 90 streamside meetings complete. There are 50 plans with referrals to implementing bodies being prepared.
- o A 1-day course on ICM was held for Local Authority staff and was well attended.
- A Blue Dots visioning workshop was held 5 March which was focussed on branding, public awareness and engagement.
- The Community Waters Fund has increased from 180k last year to 225k this year and approximately 140-150 applications have been received. The quality of applications seems to have increased.

#### **ASSAP (Noel Meehan)**

- ASSAP are making steady progress with 1247 farm visits and assessments made, and 80 farmer meetings in 68 PAAs.
- There has been a very high level of engagement (96%) although this is expected to slip slightly in future because initial contact has been made with existing Teagasc clients. 90% of farmers who engage have agreed to implement measures.
- o 75% of the pressures are from diffuse sources. The main issue is phosphorus reaching watercourses via overland flow on saturated soils and sedimentation which has been found to be a greater issue than expected. There is generally poor implementation of nutrient management plans. Moving drinking water access points and installing stream fencing are among the most challenging measures to implement, with a 50% refusal rate, because of the costs, prospect of a future grant, and/or properties being rented.
- Where new buffer margins are recommended by ASSAP in a PAA, the area inside the fence remains eligible for the basic payment scheme which is a significant recent change that should help to provide an incentive.
- The issues around data protection have been resolved but require a legislative amendment so they can be implemented.
- The focus for the coming months is to concentrate on revisiting farmers to assess whether the measures have been implemented.
- ASSAP advisors are exchanging knowledge and cross-pollinating with other Teagasc advisors. For example, 160 discussion groups have had ASSAP advisor input and there has been integration and training with the other advisors.
- 3. EPA (Marie Archbold) 3<sup>rd</sup> Cycle Areas for Action <u>see presentation on OneDrive</u>

A new approach to identifying different sorts of areas for action is being proposed which seeks to expand the reach of the river basin management plan to include water work that is being done outside of areas being managed by LAWPRO. It is proposed that these Areas for

Action would include Areas for Restoration, Areas for Protection, and Areas for Research. The general consensus was that the approach makes sense but it needs to be tweaked slightly to make sure all relevant bodies are included.

# 3. Discussion: Draft protocol and template for bringing forward issues – <u>see draft</u> protocol on OneDrive

Jenny Deakin presented a draft structured protocol and template for bringing forward and tracking issues being raised at the NTIG. The approach was welcomed and a few key points were raised:

- The issues raised need to have a national perspective, rather than be a local issue.
- It would be beneficial to go back through previous meetings and bring forward previous issues in the new template. LAWPRO agreed to trial the form.
- There was a suggestion that issues to be raised should be discussed at NTIG before they are
  written up in this format and further escalated. It was confirmed that this is the intention of
  the process.

#### 4. Focus on links with climate

The Local Authority CAROs (David Dodd, Climate Action Regional Coordinator, Dublin Region – 15 mins) - <u>see presentation on OneDrive</u>

David outlined the roles of the CAROs and some possible areas for collaboration. The Group welcomed CARO participation and membership of NTIG. Alan Dunney will represent the CAROs at future NTIG meetings.

<u>LA Climate Charter</u> may be helpful but it is ambitious and potentially quite onerous and will require a focus on implementation. The Local Authority targets are to achieve a 40% reduction in GHGs by 2030, and a 33% improvement in energy efficiency by 2030. The <u>Climate action plan</u> will define how emissions should be reduced. The <u>Heads of Climate Action bill Section 15</u> defines the LA role.

## **Update on climate discussions in the south west region (Fran Igoe, LAWPRO)** - <u>see presentation on</u> *OneDrive*

Fran updated the group on discussions on links with climate that have been taking place in the south west. Nature based solutions (or natural water retention measures) are a good example of measures with multiple benefits. The question should be asked whether drainage district schemes are fit for purpose under climate change scenarios? The key thing is to 'join up the thinking', which was the number one issue from the public consultation process from the last cycle. IFI's guidance on planning for watercourses in the urban environment was also referenced.

#### Hydrometrics Update (Conor Quinlan) - see presentation on OneDrive

A brief update was given by Conor Quinlan on work underway on abstraction risk assessments and collaboration to consolidate national climate modelling scenarios into one set that is used by everyone so that outcomes can be compared.

## Relevant research and discussion on bringing climate considerations into the river basin management plan (all)

There was brief discussion that further, more in-depth consideration of water climate links would be beneficial. It was also agreed that the messaging should be integrated across the multiple benefits as

far as possible: there is little mention at present for example about water quality in the climate adaptation documentation. It was noted that the <a href="Peace plus">Peace plus</a> programme, which is the successor to the Interreg programme could be a useful source of funding for cross border activities in this area. A future meeting might focus on relevant research.

On the 28<sup>th</sup> of February a film is due to air on PFAS contamination in drinking waters. PFAS is an emerging contaminant of interest and it may generate some media interest.

#### Appendix 1: roundtable discussion

Time for roundtable was brief due to length of climate discussions; as a result only key updates were shared with the group.

- NIEA The SWMI consultation document has been published. NIEA are continuing to try to prepare the river basin management plan(s) and decide how to set objectives.
- MI Trac monitoring on behalf of the EPA is ongoing.
- NFGWS There are a lot of synergies with the source protection work being carried out by the Group Water Scheme sector. Two new climate action and biodiversity officers have been employed and are working on developing framework documents.
- Waterways Ireland WI are working through the heavily modified waterbody designation process with EPA.
- IW IW put out a call for additional members for the steering group for their pilot source protection project. The IW national water resources plan is due to be published in April.
- Forest Service the Forest Service has a new scheme for the creation of native woodlands on public land called the Neighbourwoods Scheme.
